3) Discussion of the Head of Studies course evaluation report 2020-2021 to the Dean

The Board agreed with the report. One course should be an A assessment, as decided earlier at the meeting.

4) Discussion of future course evaluation questions

The Board's comments on the questions:

- Is it possible to add feedback about the specific TA's and can the TA's then receive this feedback?
- When do we have to send the *additional questions* for the questionnaire for the different blocks?
- The question "Please assess the following statement: The teacher facilitates a good learning environment" will be understood like this "was there a good atmosphere at the course?/was it cosy". The question should be focusing more on the students learning. The new common questionnaire will be used at SDS from spring 2022.

5) Approval of changes in the curriculum /Søren

The Board approved the changes. The changes will take effect from spring 2022.

6) Meeting dates in the autumn

The Board agreed about the meeting dates in the autumn. Jonathan will be on exchange this semester. Jonathan offered to participate in the coming meetings on Zoom. It seemed that some maybe did not like the idea of hybrid Study Board meetings.

7) Briefings and any other business

Conclusions from the feedback workshop 24 August by Søren and Andreas:

- There should be more transparency about the office hours.
- At the courses, with open-ended exams, the teacher should show the students examples of assignments.
- SDS should make a clear policy for feedback
- Andreas and Søren will discuss the suggestion to cut a lecture and use it for feedback with the teachers.
