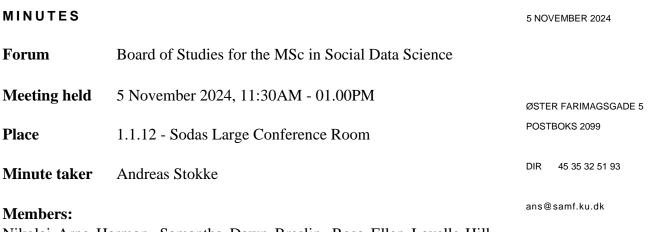

2. Orientation regarding: (15 minutes)

a. Exam complaint statistics for Fall exams 2023

Kristoffer: SDS had more complaints as a result of the summer 2023 exams.

Nicolaj: We have comparatively higher complaints compared to the other programmes. Moving forward it's a good idea to keep an eye on the number of complaints, and also on how many of them are rejected.

Andreas S. points out that a reassessment may result in a lower grade for the students. Reassessment will likely be done by another assessor.

Csilla: Students are aware that complaining likely won't change the grade.

b. Dispensation statistics for Spring 2024

c. Credit transfer statistics for Spring 2024

Kristoffer mentions that the appendix lists courses taken outside of SAMF, meaning the rest of KU and other universities.

The list is interesting with regards to the Masters reform, and the types of electives that students can expect to take.

Csilla mentions that the list might be useful for students to use when planning electives or exchange stays.

3. Hearing regarding SAMF Exam Catalog (45 minutes)

a. **Hearing:** An exam catalog has been drafted presenting the framework and guidelines for exams conducted at the faculty. The deadline for hearing answers is the same day.

Samantha mentions that there is likely an issue with regards to the SDS Basecamp course and the allowed duration presented in the catalog. Andreas S. makes a note of this.

Kristoffer mentions that the programmes are based on block strucutre while the general deadlines work with a semester structure.

a. **Orientation:** Head of Studies will brief the board on the reform of the Master's programmes.

There is a committee with all the rectors where they are dicussing programmes across all the universities. Programmes that are similar have to be based on the same conditions across the different universities.

We, along with the other short MA programmes, will be changed to 1 year programmes. From 2028 SDS will be converted.
